

Juro prize promotion terms and conditions: 12 December 2024 Advent Calendar Giveaway

1. How to enter

- 1.1. To enter this promotion, go to [\[URL\]](#) and enter the information requested. Entry is free.
- 1.2. All entries must include your name, company and business email address.
- 1.3. Entries that don't comply with these terms and conditions are void and won't be entered into the promotion.
- 1.4. You may only submit one entry to this promotion. Additional entries are void and won't be entered into the promotion.

2. Start date

The promotion starts on 12 December 2024 at 9am (UK time).

3. Closing date

The closing date for this promotion is 17 December 2024 at 5pm (UK time).

4. Selection of winners

- 4.1. There will be 12 winners of the prize draw.
- 4.2. The winners of the prize draw will be the first 12 entrants randomly selected from all entries correctly submitted in accordance with these terms and conditions.

5. Prize

- 5.1. The prize is one Juro-branded advent calendar per winner.
- 5.2. There is no alternative prize.
- 5.3. The prize is non-transferable and doesn't include any additional costs and expenses.

6. Restrictions and requirements

- 6.1. The following restrictions and requirements apply:
