### 1. How to enter

### 2. Start date

The promotion starts on 16 December 2024 at 9am (UK time).

### 3. Closing date

The closing date for this promotion is 21 December 2024 at 5pm (UK time).

### 4. Selection of winners

- 4.2. The winners of the prize draw will be the first 6 entrants randomly selected from all entries correctly submitted in accordance with these terms and conditions.
